



The Bible Museum Opened

By A. L. O. E. 1883

There are many objects of deep interest for the students of Scripture, the accounts of which have been "written for our learning", objects which we are intended to contemplate with earnest attention, and from which we can draw rich spiritual lessons.

the golden sceptre

We considered the rags of Ebedmelech in an earlier edition of Our Firm Foundation. Very different is the object of our present contemplation—the gold from the tatters, the sceptre of a powerful monarch from the rags of an African servant—and even so our theme rises from man's mercy to that of God, from the kindness of Ebedmelech to the free grace of our Lord.

For it is not on the history of Esther herself that we will now dwell, except so far as she appears an emblem of the Church, the queen all glorious within, whose clothing is of wrought gold. Let us muse on how she, and with her, every individual believer, dares to approach Him who is of purer eyes than to behold iniquity, the great and terrible God, who hath measured the waters in the hollow of His hand, and meted out heaven with the span.

It is a solemn thing to draw nigh to the King of kings

There is indeed, far too little of reverence in the way in which we too often enter by prayer the presence of our Lord. The careless posture, the wandering thought, the hastily-uttered supplication, seem to denote that Christians little realize how solemn a thing it is to draw nigh to the King of kings. Not thus did Esther approach the throne of Ahasuerus. If the traditional account preserved in the Apocrypha be true, her heart was in

anguish for fear, she turned pale, and fainted and fell. Not that God wills that such terrors should oppress His redeemed; they are permitted to come boldly to the throne of grace; they are commanded to draw near with a true heart, in full assurance of faith; but a certain degree of holy awe should be mixed with holy confidence; "...let not thine heart be hasty to utter anything before God; God is in heaven, and thou upon earth, therefore let thy words be few." Eccl. 5:2.

Our God is a consuming fire

But for the golden sceptre of grace held out to us through the mercy and merits of Christ, the sentence of death would indeed go forth against us when we appear before Him. "For our God is a consuming fire. The mountains quake at Him, and the hills melt, and the earth is burned at His presence. Who can stand before His indignation, and who can abide in the fierceness of His anger?" But the love of Persia's king for his bride was but a faint shadow of the love of the Lord for His church. "What wilt thou, Queen Esther? And what is thy request? It shall be even given thee to the half of the kingdom."

Such were the gracious words of Ahasuerus to the trembling supplicant before him; and so the Church hears the tender assurance of her King, "Ask, and it shall be given you; seek, and ye shall find. Whatever ye shall ask the Father in My name, He will give it to you."

Esther entreated preservation for herself and her people

And what was it that Esther came to entreat, when the golden sceptre of Ahasuerus was stretched out towards her?--In the first place, the presence of the king at her banquet, and, beyond this, the preservation from destruction of herself and her people. Much the same as hers is the petition of Christ's


Church to her heavenly King, only with the loftier blessings implored their order is reversed. The Church prays first for salvation, deliverance from death eternal, and then for the presence of the Lord—not for an hour or a day—but even for ever and ever.

By free grace He holds out to her the sceptre of pardoning mercy

If Esther, an orphan exile, born to bondage and sorrow, was able in royal garments to approach her lord and invite him to a sumptuous banquet which she had prepared in a palace, the robes which she wore, the feast which she spread, were all the gifts of his love. She could but offer him of his own. How strikingly does this exemplify the position of the Church in regard to her Lord! By free grace He holds out to her the sceptre of pardoning mercy; by free grace He clothes her with the royal garments of righteousness; by free grace He enables her to welcome Him and minister unto Him. He is more ready to hear than she to pray, more ready to grant than she to implore. He has loved and will love her for ever, will save her from all her enemies, and crown her with joy everlasting.

It is a token of free salvation

Such are some of the comforting thoughts suggested to us by the golden sceptre, thoughts of mercy, grace, and love. It is a sceptre, the emblem of power and dominion—a golden sceptre, reminding us of the word spoken of Christ our King, "Thy throne, O God, is for ever and ever: a sceptre of righteousness is the sceptre of Thy kingdom." It is a token of free salvation; they to whom it is extended shall live in the presence of God, shall stand accepted before Him; and it is a sceptre held out to every one who, in lowly faith, approaches Him and accepts His guidance in their lives—the One who loved and gave Himself for us.

Modern Christianity has largely forgotten the importance of the Protestant Reformation, which took place during the 1500s.

For almost a thousand years Europe had been ruled by the iron hand of Rome. Only a few Bibles existed then, and Christianity was largely permeated with superstition. Faith in Jesus Christ, heartfelt appreciation of His love, and a simple trust in His death on the cross were almost unknown. The New Testament truth about grace, full forgiveness, and the free gift of eternal life to believers in the Son of God (see Romans 6:23) had been buried under a mass of tradition.

Then, Martin Luther arose like a lion in Germany. After a period of tremendous personal struggle, Luther began teaching justification through faith in Jesus Christ, rather than through reliance on creature merits or any human works (Romans 1:16; 3:26, 28; 5:1).

"Preach the word"

Eventually Martin Luther turned to the prophecies. By candlelight he read about the little horn, the man of sin, and the Beast. He was shocked as the Holy Spirit spoke to his heart. Finally, he saw the truth, realizing that these prophecies apply to the Roman Catholic Church.

As he wrestled with this new insight, the voice of God echoed loudly in his soul saying, "Preach the word" (2 Timothy 4:2). And so, at the risk of losing his life, Martin Luther preached to an astonished people, publicly and in print, that papal Rome was the Antichrist of Biblical prophecy. Because of this dual message of salvation through faith in Jesus Christ apart from works and of papal Rome being the Antichrist, the river of history changed its course. Hundreds of thousands of Europeans left the Catholic Church.

Two great truths

"There are two great truths that stand out in the preaching that brought the Protestant Reformation," American Bible Commentator, Ralph Woodrow, reminds us; "The just shall live by faith, not by the works of Romanism, and the Papacy is the Antichrist of Scripture." It was a message for Christ and against Antichrist. The

entire Reformation rests upon this twofold testimony.

It has been said that the Reformers first discovered Jesus Christ and then, in the blazing light of Christ, discovered the Antichrist. This mighty Spirit-filled movement, for Christ and against the Antichrist, shook the world.

H. Grattan Guinness wrote these memorable words:

From the first, and throughout, that movement [the Reformation] was energized and guided by the prophetic word. Luther never felt strong and free to war against Papal apostasy till he

recognized the pope as antichrist. It was then that he burned the Papal bull. Knox's first sermon, the sermon that launched him on his mission as a reformer. was on the prophecies concerning



the papacy. The reformers embodied their interpretations of prophecy in their confessions of faith, and Calvin in his "Institutes". All of the Reformers were unanimous in the matter, even the mild and cautious Melanchthon was assured of the antipapal meaning of these prophecies as was Luther himself. And their interpretation of these prophecies determined their reforming action. It led them to protest against Rome with extraordinary strength and undaunted courage. It nerved them to resist the claims of the apostate church to the utmost. It made them martyrs; it sustained them at the stake. And the views of the Reformers were shared by thousands, by hundreds of thousands. They were adopted by princes and peoples. Under their influence nations abjured their allegiance to the false priest of Rome. In the reaction that followed all the powers of hell seemed to be let loose upon the adherents of the Reformation. War followed war; tortures, burnings, and massacres were multiplied. Yet the Reformation stood undefeated and unconquerable. God's word upheld it, and the energies of His almighty Spirit. It was the work of Christ as truly as the founding of the church eighteen centuries ago; and the revelation of the future which he

gave from heaven that prophetic book with which the Scripture closes was one of the mightiest instruments employed in its accomplishment.ⁱⁱ

The Catholic Church would not allow this movement to continue.

The Catholic Counter Reformation - The Council of Trent and the Jesuit Order

In 1545, the Catholic Church convened one of its most famous councils in history. It took place north of Rome in a city called Trent. The Council of Trent continued for three sessions ending in 1563. One of its main purposes was to plan a counterattack against Martin Luther and the Protestants. Thus, the Council of Trent became a center for Rome's Counter Reformation.

Up to this point, Rome's main method of attack had been largely frontal: openly burning

Bibles and heretics. Yet this warfare only confirmed in the minds of Protestants the conviction that papal Rome was indeed the Beast power that would "make war with the saints" (Revelation 13:7). Therefore a new tactic was needed, something less obvious. The sought after solution was found in the Jesuit Order.

Eleven years earlier, on August 15, 1534, Ignatius Loyola founded a secret Catholic order called the Society of Jesus, also known as the Jesuits.

At the Council of Trent, the Catholic Church gave the Jesuits the specific assignment of bringing Protestantism back to the "Mother Church". This was to be done not only through the Inquisition and through torture, but also through theology and deception.

The Jesuits have had a dark history of intrigue and sedition. That is why they were expelled from Portugal (1759), France (1764), Spain (1767), Naples (1767), and Russia (1820).

Jesuit priests have been known throughout history as the most wicked political arm of

the Roman Catholic Church.i

The Catholic Counter Reformation - Futurism

The Jesuits were commissioned by the Pope to develop a new interpretation of Scripture that would counteract the Protestant application of the Bible's prophecies regarding the Antichrist to the Roman Catholic Church. All the reformers' studies pointed the finger directly at the Roman Catholic Church as the Antichrist power described in Daniel as the "little horn".

Francisco Ribera (1537-1591), a

brilliant Jesuit
priest and doctor
of theology from
Spain, answered
the Papacy's
call. Like Martin
Luther, Francisco
Ribera also read
by candlelight the
prophecies about
the Antichrist,
the little horn,

the man of sin, and the beast of Revelation.

He then developed the doctrine of futurism. His explanation was that the prophecies apply only to a single sinister man who will arise up at the end of time. Rome quickly adopted this viewpoint as the Church's official position on the Antichrist.


In 1590 Ribera published a commentary on the Revelation as a counter interpretation to the prevailing view among Protestants which identified the Papacy with the Antichrist. Ribera applied all of Revelation to the end time rather than to the history of the church.

Antichrist, he taught, would be a single evil person who would be received by the Jews and who would rebuild Jerusalem.

Ribera denied the Protestant

Scriptural Antichrist (2 Thessalonians 2) as seated in the church of Godasserted by Augustine, Jerome, Luther,





and many reformers. He set on an infidel Antichrist, outside the church of God.ⁱⁱ

The result of [Ribera's] work was a twisting and maligning of prophetic truth.ⁱⁱⁱ

Following close behind Francisco Ribera was another brilliant Jesuit scholar, Cardinal Robert Bellarmine of Rome (1542-1621). Between

1581-1593, Cardinal Bellarmine agreed with Ribera in his work Polemic Lectures Concerning the Disputed points of the Christian Belief



Against the Heretics of this Time.

The futurist teachings of Ribera were further popularized by an Italian cardinal and the most renowned Jesuit controversialists. His writings claimed that Paul, Daniel, and John had nothing whatsoever to say about the Papal power. The futurists' school won general acceptance among Catholics. They were taught that antichrist was a single individual who would not rule until the very end of time.

Through the work of these two clever Jesuit scholars, Jesuit futurism was born.

The spread of futurism

For almost 300 years after the Council of Trent, Jesuit futurism remained largely within Catholicism, but the plan of the Jesuits was that Protestants would adopt this doctrine. This adoption process actually began in the early 1800s in England, and from there it spread to America.

The story of how this happened is both fascinating and tragic. Many individuals were genuine Christians but unknowingly became channels of error.

The Futurism of Ribera never

posed a positive threat to Protestants worldwide for three centuries. It did stop the Reformation in Eastern Europe. However, largely, it was virtually confined to the Roman Church. But earlier in the nineteenth century it sprang forth with vehemence as it latched on to Protestants of the Established Church of England.

Key players

Dr. Samuel Roffey Maitland (1792-1866), a lawyer and Bible scholar, became a librarian to the Archbishop of Canterbury. In 1826 he published a book attacking

the Reformation and supporting Ribera's idea of a future one-man Antichrist. For the next ten years, in tract after tract, he continued his anti-Reformation rhetoric.

As a result of his zeal and strong attacks against the Reformation, the Protestantism of England—the very nation that produced the King James Bible in 1611—received a crushing blow.

After Maitland came James H. Todd, a professor of Hebrew at the University of Dublin. Todd accepted the futuristic ideas of Maitland, publishing his own supportive pamphlets and books.

Then came John Henry Newman (1801-

1890), a member of the Church of England and a leader of the famous Oxford movement. In 1850, Newman wrote his Letter on Anglican Difficulties, revealing that one of his goals in the Oxford movement was to absorb "the various English denominations and parties" back into the Church of Rome. After publishing

a pamphlet endorsing Todd's futurism about a one-man Antichrist, Newman became a Roman Catholic, and later even a highly-honored cardinal.

Through the influence of Maitland, Todd, Newman, and others, a definite "Romeward movement was already arising, destined to sweep away the old Protestant landmarks, as with a flood."

Dispensationalism and the rapture

As the doctrine of futurism was spreading across Europe, The muchrespected Scottish Presbyterian minister Edward Irving (1792-1834), the acknowledged forerunner of both the Pentecostal and charismatic movements, came onto the scene. Irving pastored the large Chalcedonian Chapel in London with over 1,000 members.

When Irving turned to the prophecies, he eventually accepted the one-man Antichrist ideas of Todd, Maitland, Bellarmine, and Ribera. But Irving went a step further. Around 1830, Edward Irving began to teach the unique idea of a two-phase return of Christ, the first phase being a secret rapture prior to the rise of the Antichrist.

In the midst of this growing anti-Protestant climate in England arose John Nelson Darby (1800-1882). A brilliant lawyer, pastor, and theologian, Darby wrote more than 50 books on Bible subjects. A muchrespected Christian

and a man of deep piety, he took a strong stand in favor of the infallibility of the Bible in contrast with the liberalism of his day.

However, John Nelson Darby, like Edward Irving, also became a strong promoter of a pre-tribulation rapture followed by a one-man Antichrist. In fact, his teaching has become a



hallmark of dispensationalism.

John Nelson Darby laid much of the foundation for the present popular idea of removing Daniel's seventieth

week from its historical context in the time of Jesus Christ and applying it to a future tribulation after the rapture.

In spite of all the positives of his ministry, Darby followed Maitland, Todd, Bellarmine, and Ribera by incorporating the teachings of

futurism into his theology.

Thus, a link was created between John Nelson Darby—the father of dispensationalism—and the Jesuit Francisco Ribera—the father of futurism. Darby visited America six times between 1859 and 1874, preaching in all of its major cities, during which time he planted the seeds of futurism in American soil.

The Scofield Bible

One of the most important figures in the spread of these false doctrines is Cyrus Ingerson Scofield (1843-1921), a lawyer from Kansas who was greatly influenced by the writings of Darby. In 1909, Scofield published the first edition of his famous Scofield Reference Bible.

Throughout the 20th century, futurism and dispensationalism became popular through books marketed to Christians.

In the early 1900s, the Scofield Bible became so popular among American Protestants that it was necessary to print millions of copies. Yet, in the much-respected footnotes of this very Bible, Scofield injected large doses of futurism also found in the writings of Darby, Todd, Maitland, Bellarmine, and Ribera.

Through the Scofield Bible, Jesuit futurism spread successfully across America. The doctrine of an Antichrist still to come was becoming firmly established inside twentiethcentury American Protestantism.




The Late Great Planet Earth

The Moody Bible Institute and the Dallas Theological Seminary have strongly supported the teachings of John Nelson Darby, and this has continued to fuel futurism's growth. Then in the 1970s, pastor Hal Lindsey, a graduate of Dallas Theological Seminary, released his blockbuster book The Late Great Planet Earth. This volume brought futurism to the masses of American Christianity and beyond. The New York Times labeled it, "The number one bestseller of the decade." Over 30 million copies have been sold, and it has been translated into more than 30 languages.

The <u>Left</u> <u>Behind</u> Series

Then came_ Left Behind. In the 1990s, Tim Lahaye and Jerry Jenkins took the future oneman Antichrist idea of Lindsey, Scofield, Darby, Irving, Newman, Todd, Maitland, Bellarmine, and



Ribera, and turned it into "The most successful Christian-fiction series ever", according to Publishers Weekly.

Hal Lindsey's book was largely theological, which limited its appeal, while <u>Left Behind</u> is a sequence of highly imaginative novels. According to Entertainment Weekly, the series is "overflowing with suspense, action and adventure", a "Christian thriller" with a label its creators could never have predicted: "blockbuster success".

The television ministries of Jack Van Impe, Peter and Paul Lalonde, and Pastor John Hagee have all worked together to produce Left Behind: The Movie. The entire project has even caught the attention of The New York Times and The Wall Street Journal, resulting in an interview of Tim Lahaye and Jerry Jenkins on Larry King Live.

The authors of <u>Left Behind</u> and the leaders of these television ministries are genuine Christians who are doing their best to influence people for God's Kingdom. Yet, in the full light of Scripture, prophecy, and the Protestant Reformation, something is terribly wrong.

<u>Left Behind</u> teaches much of the same Jesuit futurism of Francisco Ribera, hiding the real truth about the Antichrist. Through <u>Left Behind</u>, the floodgates of futurism have been opened, unleashing a massive tidal wave of false prophecy, which is now

sweeping over America.

As we have already seen, the theological foundation for the entire Left Behind series is the application of the seven years of Daniel 9:27 to a future period of tribulation. This separates the 70th week away from the first 69 weeks in the 70-week prophecy, putting it at the end of time. Remember, one of the first people to do this was Iesuit Francisco Ribera:

Ribera's primary apparatus was the seventy weeks. He taught that Daniel's seventieth week was still in the future...it was as though God put a giant rubber band on this Messianic time measure. Does this supposition sound familiar? This is exactly the scenario used by Hal Lindsey and a multitude of other current prophecy teachers.

When most Christians look at the last 1500 years, how much fulfilled prophecy do they see?

None. Because almost everything is now being applied to a future time period after the rapture.

As we have seen, this idea of separating the weeks originated with the Jesuits, and its insertion into the majority of 21st-century prophetic teaching is now blinding millions of hearts and eyes to what has happened, and is happening, in the Church.

It is this theory that permeates Futurism's interpretation of all apocalyptic prophecy. i Jesuit futurism has now become like a 300-pound boxer with spiked gloves. With an apparently all-powerful punch, it has almost knocked Protestant historicism entirely out of the ring: The proper eschatological term for the view most taught today is futurism...which fuels the confusion of dispensationalism. The futuristic school of Bible prophecy came from the Roman Catholic Church, specifically, her Jesuit theologians...however the alternative has been believed for

centuries. It is known as historicism.ⁱⁱ

It is a matter of deep regret that those who hold and advocate the futurist system at the present day, Protestants as they are for the most part, are thus really playing into the hands of Rome, and helping to screen the Papacy from detection as the

Antichrist.iii

Who had the right theology—those who were burned at the stake for Jesus Christ, or those who lit the fires?

Who had the true Bible doctrine the martyrs, or their persecutors?

Who had the correct interpretation of the Antichrist—those who died trusting in the blood of Christ, or those who shed the blood of God's dear saints?

Jesuit futurism's aim is to deny the Protestant Reformation's application of prophecy, giving the Vatican an

In fact, Jesuit futurism is at war with the prophecies

of the Word of God itself. And if that's not enough, consider this: Jesuit futurism originated with the Roman Catholic Church, which makes it the very doctrine of the Antichrist.



When Christian ministries and movies like A Thief in the Night, Apocalypse, Revelation, Tribulation, and Left Behind: The Movie proclaim an Antichrist who comes only after the rapture, what are they really doing? They are sincerely and unknowingly teaching the doctrine of the Antichrist.

We live in a time when obedience is characterized as legalism, prophecy is viewed as some sort of optional study because no one can accurately understand it, and the love of Jesus overrides any rational reasoning, essentially voiding the Word of God.

Along with the relativistic attitude so popular today, it is no wonder that, according to a Barna Group study, 55% of American pastors do not believe in the Bible anymore as the unerring Word of God. While the

Bible has its good points, they say, it is not to be taken too literally.

The Bible explains itself

The sad truth is, however, that rarely does a congregation rise much above the pastor or church

leadership. Most people simply accept what comes from the pulpit without checking its accuracy in the Word of God.

We are no longer people of the Book. Instead we follow the majority. There is a perceived safety in numbers. The majority of Christians can't be wrong, can they? Hasn't God appointed these pastors to their positions? But sadly, church leadership throughout Bible history has often been wrong.

Although futurism may be a comforting doctrine, it demands a faith that has no justification or fulfillment in the Bible or any history



book. The Bible must be its own expositor. Letting the Bible explain itself allows for no other private interpretation. The Bible calls itself a double-edged sword:

For the word of God is living and powerful, and sharper than any twoedged sword. Hebrews 4:12 NKJV


God loves everyone and calls us to love everyone

It is never comfortable to have error exposed—not to the one having to say it nor to the one listening. It is always much easier to compromise or to say nothing. God has patience with each one us, and leads us to truth as we are able. All Christians are growing as God leads them.

Historicism is the belief that Biblical prophecies about the little horn, the man of sin, the Antichrist, the Beast, and the Babylonian harlot of Revelation 17 all apply to

the developing history of Christianity

and to the ongoing struggle between Jesus Christ and Satan within the Church, culminating at the end time. Historicism sees these prophecies applying to papal Rome as a system whose doctrines deny the New Testament message of free salvation by grace through simple faith in Jesus Christ. Historicism was the primary

prophetic viewpoint of the Protestant Reformation.

In direct opposition to historicism, and rising up a razorsharp counterattack against Protestantism, was the Jesuit viewpoint of **futurism**. Futurism states that the Antichrist prophecies have nothing to do with history or papal Rome but rather apply to only one sinister man who comes at the end of time.

Jesuit futurism sweeps 1500 years of prophetic history under the proverbial rug. This is accomplished through a theory


that says when Rome fell, prophecy stopped, only to continue again right

around the time of the Rapture. Thus, the ten horns, the little horn, the Beast, and the Antichrist have nothing to do with Christianity today. According to this viewpoint, no prophecies were being

fulfilled during the Dark Ages.

Dispensationalism is the theory that God's dealings with humanity are divided into major time periods, or dispensations. According to John Nelson Darby, we are now in the "Church Age" until the rapture. After the rapture, the seven-year period of Daniel 9:27 will supposedly kick in, when the Antichrist will rise up against the Jews.

HOW TO KILL A VAMPIRE... MYTH

My message this month is on how we can kill a myth... specifically the vampire myth, and other such assorted myths.

Vampire myths have been around for a long time and there are people who believe in such things. I have a friend from Transylvania and he actually even talks a little like Count Dracula. I've not met the man personally, but I consider him a friend. We met over the phone and by internet and have "known" each other for a few years now. He makes his own potions, otherwise known as liquid herbal supplements. They are actually quite good and are very successful against a variety of diseases like cancer, diabetes, liver problems, digestive issues, etc. He lives in Canada now, which kind of surprised me, since that is a long way from Transylvania. He was educated as a "water engineer" in Israel, of all places, and immigrated to Canada because the province of Alberta,

Canada has the highest concentration of canals for irrigation in the world, according to him.

My "brother", Gavriel, from Transylvania...

As I have gotten to know Gavriel better, and we have become closer friends, he has told me a little more about his past. I have a tendency to make friends rather quickly and I also have a habit of calling people "brother" or "sister". So, when Gavriel would call me, I would say,

"My brother, how are you?" He seemed to get a kick out of that, and now always calls me his brother as well. As a matter of fact, he threw one of the staff here at Hope for a loop

a while back when he called. The staff member answered the phone and Gavriel asked for me, and he was asked who he was, and he said, "Tell Joe his brother is calling." Now, I just happen to have three brothers, and one of the three works here at Hope. So when the phone rang in my office, and I picked it up, the staff member said that my "brother" was on the phone. I said, "Danny?" my brother who worked here? And I was told, rather cryptically, "No, I don't think so."

So, I picked up the phone expecting to hear one of my other brothers, David or Mark, talking to me, but Gavriel answered, "My brother, how are you?" with a hearty, full-throated

laugh. As a result of our good-natured camaraderie, we have become fairly good friends. I'm telling you this so you will understand why I asked him what I did. We were

good enough friends that I figured he would not be offended. When he told me that he was originally from Transylvania, and remember, he has quite the accent... I couldn't resist. I asked him if he was a vampire and if he had any desire for blood.

The older the myth, the more believable it is

He laughed, as I thought he would, and asked me if I would like to know where that myth came from. I said, "Absolutely." I always like hearing the truth about something. I have never seen the show, but I understand there is a program called "Myth-busters" and I assume from the title that the show must be about busting or debunking myths. So apparently, there are many people like me who want to know the truth from the myth. There are so many things that people think are true because they have either heard it from someone or read about it somewhere. And the older the myth, the more

believable it is. The more people who believe it, the more accepted it becomes. There are all sorts of myths.

Did you know people once believed that a really strong man named Atlas held up the world? Most people have heard that about everyone on the planet once believed the world was flat and that if you sailed far enough on the ocean, you would fall off the edge. These were myths. And, according to my friend Gavriel, Transylvanian vampires were a myth too.

Vlad Drakulya, aka Vlad the Impaler

He said, "There are two parts to this myth. The first part is about a Romanian leader called Vlad Drakulya." He was known as Vlad the Impaler because of his cruel means of inflicting death on his enemies. Gavriel said that Vlad's father was in charge of a certain geographical area,

later known as Transylvania, and when he was killed, young Vlad was taken prisoner to the Ottoman Empire where he was regularly beaten and whipped. Gavriel said that Vlad was kept in a room for many years,

never seeing the light of day. As a result, he went insane. Finally, he was released, and was allowed to take his father's throne. When he ascended the throne, being crazy, he impaled anyone he felt could or might be a threat.

The perfect recipe for vampires

The second part of the myth of the Transylvanian vampires was the issue of blood. In those days, the aristocracy wanted to maintain power by any means necessary. This usually meant trying to keep the power in the family. In order to keep it, "in the family" there ended up being a lot of inter-marrying within the family. As a result of this smaller gene pool, several of the members of the ruling family developed hemophilia. Hemophilia, as you know, is a disease that causes your blood not to clot, and one can easily bleed to death. And there were many myths as to how to treat the disease of hemophilia. As you might begin to imagine, it was thought that if you drank blood, you could cure your hemophilia.

Well, put together an evil, insane monster who impaled people and was named Dracula, and others from the area who drank blood, and you have the perfect recipe for vampires. This, Gavriel said, is where the whole story comes from in Transylvania. "There is absolutely no truth to any of those myths," he said.

There is money in perpetuating the myth

And as I thought later about the many myths that have arisen over the centuries about this beautiful place called Transylvania, I wondered why the truth does not come out.
Gavriel knew the truth. No doubt many others know it as well. Now,

I knew the truth. And now... you, too, know the truth. So, shortly, there should be no more misconceptions about Dracula and vampires and Transylvania... right?

But some myths are really hard to kill. Some myths hang on for years and years and years. Why? Well, in the case of Dracula and vampires... there is a lot of money to be made. There are a lot of movies and actors and books about vampires. If it is found out that the whole mess started because of an insane person and

some really stupid medical advice... then everything would come to a screeching halt. So, to keep the money pouring in, we need to keep the myth alive.

The Bible is the original myth-buster

Do you suppose there are other myths kept alive because of ulterior motives? Do you think that maybe,



reasoning? What about where people go when they die? I've heard they go to heaven. Or if you have been bad, that you go to hell. Or if you were not too bad, that you might end up in purgatory. Or you turn into a worm or a pretty bird, depending upon how you lived your life. And I've also heard that you simply sleep in the grave until Jesus comes. Which is myth, and which is true? And where did the myths come from? Who made these things up?

Well, the best case scenario is to find out from the people who were there in the beginning. God said that He was there from the beginning. And He gave us a book to direct us in the right paths. It is the original myth-buster. If you want to know the truth, read God's word.

The myth about Sunday worship

And speaking of God's word, that reminds me of another myth. The Bible says to keep the seventh day of the week, or Saturday. But there has been this myth going around that we should keep the first day of the week, or Sunday. Who started this myth? When did it start?

Well, to make a really long story short, the myth got its start about a

hundred years or so after the last of the disciples of Jesus were dead. The church during the early years of the apostles, or disciples, stayed fairly on course and did the right things. You can read all about it in the Book of Acts. That's the history of the early church. It was after the original disciples were dead and gone that things started going a little sideways. Saturday and Sunday. Saturday for the Sabbath-keeping Christians and Sunday for the "Sun" worshipers. But the church needed a reason to keep the "sun" day. And they found it in the day that Jesus rose from the dead....Jesus kept the Sabbath, by resting in the grave and He arose on Sunday morning. Perfect!

Then it was suggested to make

They started making Sunday a day of rejoicing and parties and lots of food and fun. The Sabbath was to be a day of fasting and mourning and quiet time.

Well, guess how long it took before most of the people started clamoring for Sunday worship over Sabbath worship. Now mind you, the Bible and the disciples did not make these

> new rules... this was the church leadership who wanted more people in the church, which meant more power.

You see how the myth was propagated? There was a lot more to it and I am distilling it down into a few sentences that took hundreds of years to accomplish, but in essence, that is how the myth got started.

There is much more money in Sunday-keeping than in Dracula movies

Just like with vampires, there is a lot of money to be lost, if you quit believing the myth. Can you imagine if all the people in

Sunday churches came back to the Bible Sabbath? What would happen to all those pastors and their salaries? What would happen to all those churches? What would happen to the millions and billions of dollars that flow into these Sunday organizations? I mean, we are talking mega-bucks here... a lot more money than is made on vampire movies. Not to mention the fact that there could be a lot of heartburn from people who have been taught the wrong thing all their lives. Not too many people will get real upset if they spent \$9.00 for a ticket to see a vampire movie, only to find out there is no such thing as vampires. But what if you have been giving thousands of dollars to a church, and going to a church for 50 or 60 years, only to find out you have been going on the wrong day??? No, there could be some real frustration over that.

Politics in the church is not too different from politics in the government

I know this will come as a shock to most of you, but infighting started in the church, and there were those who began politicking for leadership. Well, as in most things in this world, the more people on your side, the better chance you have of winning. So there became a desire to get more people on your side in the church. Once you have all of the people in the church on one side or the other, the only way for the loser to win is to get more people to come into the church, who then come to your side. Politics in church is not too different from politics in the government. Lower the standard and promise people things for free, and you will often get more people on your side.

The "perfect" reason for Sunday worship

There were a lot of religious people in the world in the time of the apostles and after, but many of them were sun worshippers, and worshipped on the "sun" day. There was a desire to bring these "sun" worshippers into the church. But these worshippers didn't want to change the day they worshipped.


Then there was the idea of all the idols that they worshipped too. They didn't want to give those up either. What to do? It was then suggested that the church keep both days...



statues of the saints so the sun worshippers could continue to worship idols. We just changed the names on the idols. The decision was made to incorporate both days as worship days. Can you see how the myth got started? Sunday wasn't God's holy Sabbath... Saturday was. But Sunday worship got started to increase membership and sway votes for one leader or another.

Sunday was a day of partying and rejoicing and feasting

Well, after a while, it got really inconvenient to keep both days. And since so many of the worldlings were Sunday worshippers anyway... why not just change the day of Christian worship to Sunday? But to be really clever about it, knowing that the church would not just go along with an automatic change of the day of worship... they decided on a plan.



What's the big deal about worship?

But what do you do when you find out the truth? What do you do when you realize that Sunday worship is a myth, except of course to the sun worshippers? What happens when you realize that God never changed His day of worship... and that it was political operatives within the faith that did it? I can tell you that many people, if not most people, recognize that vampires are a myth. But they go to the movies anyway because they enjoy the shows and what's the harm, they think? There are also many people that know the truth about the Sabbath and Sunday worship, and they feel the same way... what's the harm? "Who cares what day we worship?" "What's the big deal?" "As long as we keep one in seven.... that's all right... isn't it?"

Have you heard that? Have you said it? Do you believe it? God said to keep the Sabbath, or Saturday. Not man, not a church leader, not mommy or daddy. GOD said to do it. In essence, when we ask these questions about keeping Saturday or Sunday, we are in fact asking if we really, really have to do what God says. Well, when you put it like that, it seems fairly clear.

Leave my myth alone!

So, what should we do? How about we just not put it that way? Let's not state it in such emphatic terms. In other words, can't we just go on believing the myth and that be okay? We really liked it when we believed the myth. We don't have to change

our lives if the myth continues.

But the problem with a myth, is that it is a *myth*... it's not true. You can believe that drinking blood might cure you of hemophilia, but since that is just a myth, it won't really help.

You can't get to heaven on a myth

What about going to heaven? Do you want the truth about getting there... or are you good with a myth? There is a story in the Bible about a man who asked Jesus to tell him how to receive eternal life. It's found in Matthew 19:16-17 ~ "And, behold, one came and said unto him, Good Master, what good thing shall I do, that I may have eternal life? And he said unto him, Why callest thou me good? there is none good but one, that is, God: but if thou wilt enter into life, keep the commandments." This is what Iesus answered the man... "keep the commandments". You know... the Ten Commandments. Jesus even repeated some of them to him.

Now what if someone told you that there are new commandments?

Now the rules are:

- 1. Do what you want.
- 2. Lie, cheat and steal... no problem.
- Adultery... fornication... God doesn't mind.
- 4. Be selfish, inconsiderate and totally impolite.

And that's about it. No other "commands". And say you followed those rules "religiously". When it is time to go to heaven, and you come up before the bar of God... how do you think your mythical rules will work for you? If God said the seventh day – and we come up to Him and we say, "Well, we decided to keep a different day... but we did do it in Your honor...", how well do you suppose that will go over?

Does Jesus really mean what He says?

My wife and I have raised 5 children. I have on a number of occasions told my teenage children to be home at a certain time. If I said to be home at 11:00 p.m., it was never acceptable to me for them to come home at 3:00 a.m. and tell me that they just decided to pick a different hour. Would it be acceptable to you? And believe me, my children have said to themselves... "Well, I don't think he *really* meant 11:00 p.m." You have my permission to call them and ask them if I meant it or not. Do you think Jesus meant it?

Kill a myth and follow the Truth!

I want to go to heaven. I want to live forever. I want to be in the city of God. Here is what the Bible says about how I can do that... how you can do that. "Blessed are they that do his commandments, that they may have right to the tree of life, and may enter in through the gates into the

city." Rev. 22:14. No myths; no pleasing fables. Just plain old Bible truth. Do you want to be with Jesus? Do you love Jesus? This is what Jesus said... "If

ye love me, keep my commandments." John 14:15.

How do you kill a myth? With truth. Jesus said He was the truth. We are safe, if we listen to and follow the Truth.

The Faith that Works by Love

"And, behold, a certain lawyer stood up, and tempted him, saying, Master, what shall I do to inherit eternal life?" Jesus replied: "What is written in the law? how readest thou? And he answering said, Thou shalt love the Lord thy God with all thy heart, and with all thy soul, and with all thy strength, and with all thy mind; and thy neighbor as thyself." Christ said unto him, "Thou hast answered right; this do, and thou shalt live." Here is a plain question

plainly answered. The condition of eternal life is explicitly defined. It is to love God supremely, and our neighbor as ourselves. This is the principle that underlies God's law, which is holy, just, and good.

Who is my neighbor?
But the lawyer, willing to justify himself, said unto Jesus, "And who is my neighbor? And Jesus answering said, A certain man went down from Jerusalem to Jericho, and fell among thieves, which stripped him of his raiment, and wounded him, and departed, leaving him half dead. And by chance there came down a certain priest that way; and when he saw him, he passed by on the other side. And likewise a Levite, when he was at the place, came and looked on him, and passed by on the other side. But a certain Samaritan, as he journeyed, came where he was; and when he saw him, he had compassion on him, and went to him, and bound up his wounds, pouring in oil and wine, and set him on his own beast, and brought him to an inn, and took care of him. And on the morrow when he departed, he took out two pence, and gave them to the host, and said unto


him, Take care of him; and whatsoever thou spendest more, when I come again, I will repay thee. Which now of these three, thinkest thou, was neighbor unto him that fell among the thieves? And he said, He that showed mercy on him. Then said Jesus unto him, Go, and do thou likewise."

This great moral standard

Without holiness, no man shall see the Lord; and only by obeying the dictates

> of God's will, can you make it manifest that you have attained to this perfection.


With many, self stands supreme There are many who congratulate



Editor's note: A series of articles on the "Latter Rain" by the above author appeared in the Review and Herald from June 3 to August 12, 1943. This subject is even more important today as we draw closer to the second coming. We continue here with the 4th article of the series.

Diet and Disease Part 2: Alkalize or Die





Last month we talked about pH. I explained what it is and some of the ways we add to or take away from the acidity in the body (mainly through diet). I mentioned some health problems that you can run into if your body becomes too acidic and cannot get rid of the acid fast enough, and explained briefly one of the pH "buffer systems". This month I'll be giving you even more information about what can happen if you become too acidic and I'll show you a sample list of foods, both acid-forming and alkaline-forming. That being said, let's jump right in!

Most people eat diets high in acid-forming foods

When people encourage you to "alkalize" your body, most of them mean that you should eat plenty of foods that have an alkaline-forming effect on your system to reduce the


workload on these buffer systems and help reduce the chances of additional health problems. The reason for making this suggestion is that **most** people eat diets very, very high in acidforming foods. An imbalanced diet high in acidproducing foods such as animal protein, sugar, caffeine, and processed foods



puts pressure on the body's regulating

In addition to all this, research shows that unless the body's pH level is slightly alkaline, the body <u>cannot</u> heal itself. So no matter what means you choose to take care of your health, it <u>will not be effective until the pH level is balanced</u>. If your body's pH is not balanced, for example, you cannot effectively assimilate vitamins,

minerals and food supplements. Your body pH affects everything.




An acidic pH can occur from an acid-forming diet, emotional stress, toxic overload, and/or immune reactions or any process that deprives the cells of oxygen and other nutrients. The



body will try to compensate for this acidic pH by using up your alkaline minerals. If you're taking in too many acids too fast with not enough alkaline to balance it out, a build up of acids in the cells can occur leading to acidosis (a condition of being too acidic). Acidosis will decrease the body's ability to absorb minerals and other nutrients, decrease the energy production in the cells, decrease it's ability to repair damaged cells, decrease it's ability to detoxify heavy metals, make tumor cells thrive, make it more susceptible to fatigue and illness, and can cause a number of health problems, including:

- Cardiovascular damage
- Weight gain, obesity and diabetes
- Bladder conditions and kidney stones
- Immune system deficiency and a tendency to get infections

- Hormonal problems
- Premature aging
- Osteoporosis and joint pain
- Leg cramps and spasms
- Aching muscles and lactic acid buildup
- Lack of energy and chronic fatigue
- Slowed digestion and elimination
- Yeast/fungal overgrowth
- Loss of drive, joy, and enthusiasm with depressive tendencies
- Becoming easily stressed
- Headaches
- Inflammation of the corneas and eyelids
- Loose and painful teeth with inflamed, sensitive gums
- Cracks at the corners of the lips, and mouth ulcers
- Stomach ulcers, excess stomach acid and gastritis
- Thin nails that split easily
- Dull hair with split ends
- Hair that falls out easily
- Dry skin that is easily irritated

Acidosis, an extended time in an acidic pH state, can directly result in rheumatoid arthritis, diabetes, lupus, tuberculosis, osteoporosis, high blood pressure, most cancers and much more.

underages. What is the best specific diet for proper pH balancing? Since the body naturally produces some acids, in order to keep the pH at a neutral level, you're going to have to eat more alkaline foods than acid foods. Doesn't this make sense? To maintain health, the diet should consist

of, at the very least, 60% alkaline-forming foods, and at the very most, 40% acid-forming foods. But the healthiest proportion (the best for restoring health) consists of 80% alkaline forming foods and only 20% acid forming foods. The great part is, as you may have guessed, the alkaline foods tend to be the most nutritious and healing foods, so eating a majority of these foods is helpful in many ways!

The following lists indicate
which common foods have an
alkaline-forming effect on your
body fluids, and which ones
are acid-forming. Please note
that these lists of acid and
alkaline-forming foods are
not comprehensive, nor are
they meant to be. This

as a general guide

Notes about food groups:
Grains:

acidifying foods.

Most beans and



grains are acid forming due to their high protein content. Whole grains and beans/legumes are very nutritious though – don't avoid whole grains completely; simply complement whole grains with foods that raise the pH.

Meat/Animal products: During digestion the nucleic acids (RNA, DNA) of meat and dairy are broken down (metabolized) to uric acid. Protein is broken down to amino acids; amino acids lower pH. Meat, dairy and some plant foods are high in protein.

Fruits/Veggies: Most fruits and vegetables have a low pH because of their acid content. But most fruits and vegetables are alkaline-forming because during digestion the acids are broken down, leaving only the high potassium content, which is alkaline-forming. Poor digestion may not break down acids well, which could make fruits and vegetables *less* alkaline forming. Improving digestion is vital to proper body pH!

Alcohol: Most beverages made with alcohol have a low pH and are acid forming because of the alcohol content. Wine, beer, whiskey, rum, etc. are acid forming.

Other: Coffee, decaf, or tea daily can cause a thiamin deficiency. Food and food products that cause thiamin deficiency lower pH. (1)



So what can you do? The <u>diet</u> is the best way to naturally bring your pH back into balance, saving the buffering systems to do just that, to buffer the minimal overages or

FACT: To neutralize just one glass of cola with a pH of 2.5, it would take 32 glasses of alkaline water with a pH of 10 (much more alkaline than normal water)!


you generally eat? If you're eating a lot of acid-forming foods, your body quickly steps in to help counteract it and get it balanced again through the buffer systems – but sometimes with dire consequences!

Becoming Too Alkaline

While we've spent a great deal of time addressing how to avoid becoming too acidic, there is also a chance that you could become too alkaline. Although rare, it can occur when you eat a very strict diet (such as a raw diet) along with taking nutritional supplements (which is possible for some of our readers). Just keep in mind that there are health risks associated with this as well. So if you're eating a diet high in raw foods and supplements, it's a good idea to buy some pH test strips or a pH meter to keep an eye on your pH.

Acid And Alkaline-Forming Effects Of Common Foods

Alkalizing foods are a result of a high alkaline-forming mineral



content, most often potassium, calcium, magnesium, and zinc. Fruits and vegetables make up almost all of the foods that are significantly alkaline-forming, while most grains, animal foods, and highly processed foods have an acid-forming effect on your body.

If you're wondering why grains and beans are on the "acid" list, remember, you DO need a healthy balance of both acid and alkaline foods. While the alkaline-forming foods are very important, the acid-forming foods have their place too (20-40% of the diet!). If after all this you're thinking, well, COOL! My body NEEDS some acidic food to balance out the alkaline food (you said 20-40%, right?!), I'll just choose meat, cheese, and soda as MY acids as long as I eat plenty of fresh fruits and vegetables along with it! Right? Wrong. While this seems like it would make sense, there are many other aspects of the foods that we're eating besides pH.

pH Testing: How to know your levels

Outside of the way you feel, the only way to know if your pH is in a

healthy range is to test it with pH paper or test strips like our Alkalive pH Strips. It is a simple and convenient way to measure how well your body is reacting to your diet and see if you need to make any changes. Saliva pH gives a good indication of what the average pH of the body was about 30 minutes to an hour ago. For an accurate measure of saliva pH, it's is necessary to measure saliva pH an hour or more after drinking or eating

anything at all, including pills of any kind, two hours if a large meal was eaten. Digestive acids will push saliva pH down, so you don't want any digesting occurring when measuring saliva pH. The goal is to keep saliva pH above 6.7 and below 7.5.

Morning urine pH is a common measure and is the result of food intake, pills, etc. throughout the day of the day before. Generally, urine pH is out-of-date information. Saliva pH is much closer to real-time information if you want to see if what you're doing is making a difference in normalizing your pH. Test your pH morning and night

for a week to get a good idea of where

your body is at and make the necessary changes to your diet to make sure vou're at the optimal level! It's simple and easy to test at home!


