## Graduation Rates

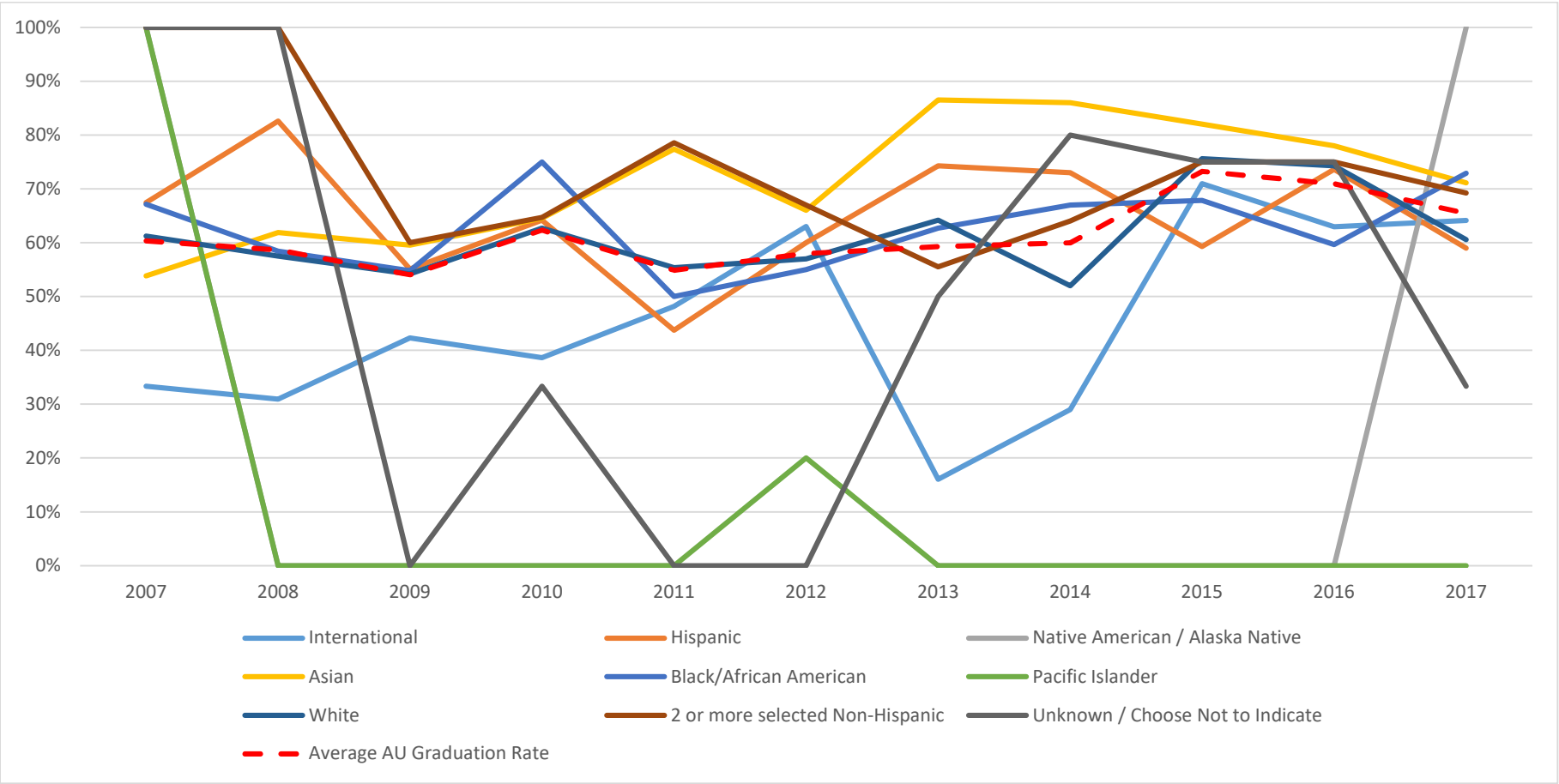
4-year average completion or graduation rate calculation (Total Completers within 150% / Adjusted Cohort 2017) = 67%

4-year average transfer-out rate calculation (Total Transfer-out Students / Adjusted Cohort 2017) = 13%

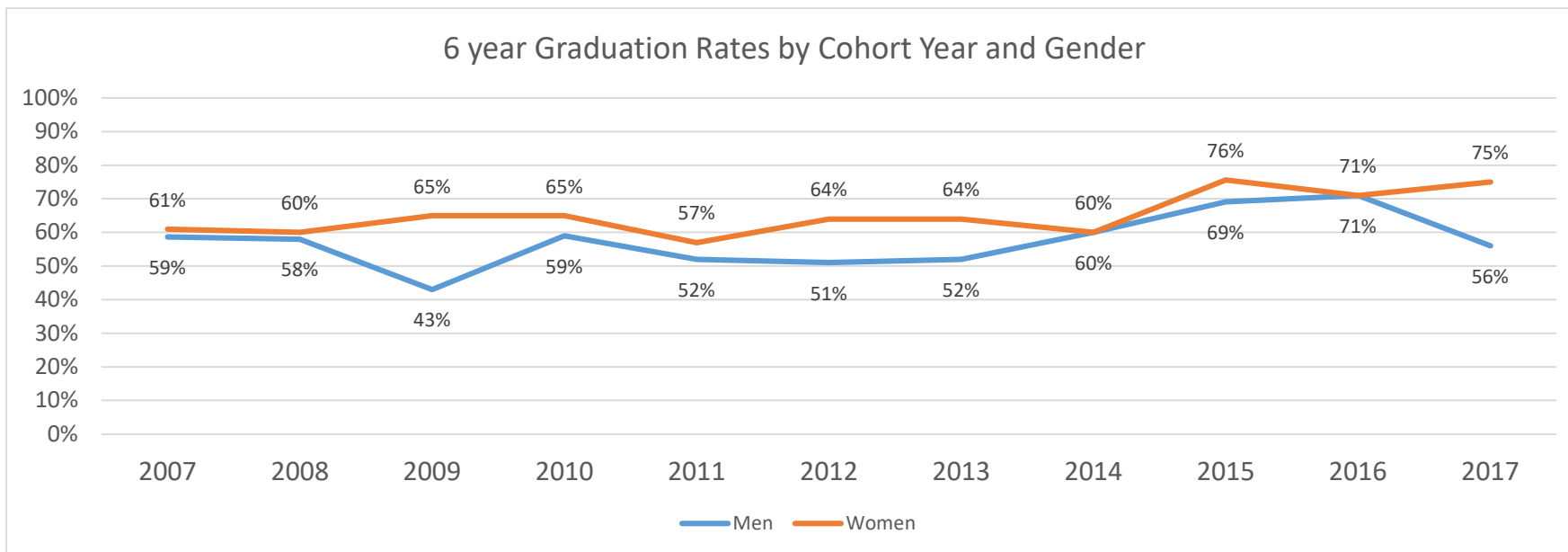
